

# Tiegerman Schools iPad Agreement

**We acknowledge that we have received the following documents and have read and understand them:**

## Student Pledge for iPad Use

1. I will use my iPad for educational purposes.
2. I will neither alter nor attempt to change, disable, or circumvent the management settings, content filters, or virus protection software on my iPad.
3. I will not install or download software that is not approved by administration or teachers.
4. I will take good care of my iPad and understand that I will be issued the same device each year.
5. I will never leave my iPad unattended in an unsecured or unsupervised location.
6. I will never loan out my iPad to other individuals.
7. I will know where my iPad is at all times.
8. I will store my iPad in a safe place.
9. I will charge my iPad's battery to full capacity each night.
10. I will keep food and beverages away from my iPad since they may cause damage to the device.
11. I will not disassemble any part of my iPad or attempt any repairs.
12. I will report any issues with the iPad to my teacher or Principal at school.
13. I will protect my iPad by always carrying it in my Tiegerman Schools-issued carrying case or in a secure manner to avoid damage and take all responsible precautions to prevent careless or intentional damage.
14. I will not decorate (stickers, adhesives, drawings) or write on the iPad.
15. I will not remove the iPad from its otterbox case unless instructed to do so by my teacher or Tiegerman staff.
16. I understand that the iPad I am issued is subject to inspection at any time without notice and remains the property of Tiegerman Schools.
17. I will follow the policies outlined in the iPad Procedures and Information Handbook for Parents and Students and the Tiegerman Schools Internet Use and Internet Safety Policies.
18. I agree to return the iPad, charger, and carrying case in good working condition at the end of each school year or when instructed to do so by Tiegerman staff. .
19. I agree to return the iPad to the Tiegerman Schools upon graduation, suspension, expulsion, enrollment termination or withdrawal from the Tiegerman Schools or when instructed to do so by Tiegerman staff.
20. I will accurately represent myself at all times while keeping further personal information such as my address or phone number private.

## Student and Parent/Guardian(s) Pledge for iPad Use

21. I/we understand that iPads are intended solely for educational use and that students are not permitted to download any digital content or applications not authorized by their teachers or approved by Tiegerman Schools administration.
22. I/we understand that the Tiegerman Schools may require me to file a police report in the event of theft or vandalism.
23. I/we agree to pay the full replacement cost of my iPad (or any part of), charger and/or case in the event that any part becomes broken or damaged (by any means other than normal use or wear- and-tear), in accordance to the following:
  - **Accidental Damage (after 1st instance), Intentional Damage, Loss of iPad:** The student/parent will be charged for repair and/or replacement up to full replacement cost of \$300 (or a higher amount depending on cost at time of repair/replacement).
  - **Powercord:** Cost for a lost power cord is \$40 (or a higher amount depending on cost at time of repair/replacement)
  - **Case:** Cost for a lost case is \$18 (or a higher amount depending on cost at time of repair/replacement)

24. I/we understand my/our responsibilities with respect to the care and maintenance of the iPad.
25. I/we understand that students must return their iPad at the end of the school year or when instructed to do so by Tiegerman staff in the condition in which it was received.
26. I/we understand that I must report any problems or damage to the iPad to the school administration.
27. I/we understand that the Tiegerman Schools reserves the right to conduct unannounced inspections of student iPads.
28. I/we understand that the use of iPads will be governed by all terms and conditions of Tiegerman Schools' policies and regulations, including but not limited to the Tiegerman Schools Internet Use and Internet Safety Policies, Tiegerman Schools iPad Procedures and Information Handbook for Parents and Students and this Agreement.

**iPads and accessories must be returned to Tiegerman Schools at the end of each school year or when instructed to do so by Tiegerman staff. Students who graduate early, withdraw, are suspended or expelled, or terminate enrollment at Tiegerman Schools for any other reason must return their iPad and its accessories on the date of termination. Failure to hand in your iPad under any of these circumstances will result in you being financially responsible for the replacement cost.**
